Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Students/families, school staff and community partners were surveyed in April 2021 to identify areas of greatest student need and challenges faced during the 2020-2021 school year, focusing on barriers to success in learning. From these surveys, staff identified the areas of greatest need and developed a plan to address learning loss through extended instructional learning time, enhancing in-person learning supports and continuing to expand access to technology for credit deficient pupils.

Urban Corps will utilize ELO grants to support all students in the charter school. Our population is 100% unduplicated. Further, students are at high risk of not graduating. All students are credit deficient and in need of additional supports following distance learning in the 2020-2021 school year. The school will continue to monitor students' academic progress through diagnostic tests, deficient credit assessments, and weekly academic grade monitoring. Further, the specific needs of students will be assessed through referrals to case

management for supports via teacher recommendation, tiered intervention identification, and self-referral. Our tiered intervention approach monitors students' attendance, behavior, and academic progress and intervention teams identifies and offers the needed supports.

Students will be informed of the opportunities and supports through emails notifications, public hearings, intervention meetings and announcements made on the school website. Opportunities will be made available to all students.

A description of the LEA's plan to provide supplemental instruction and support.

Supplemental support for all students will be provided through the addition of instructional aides (accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports) especially in the areas of English Language Development, remedial Mathematics, and in support of students at risk of not graduating (including those that are credit deficient). Instructional aides will be assigned to classrooms with the greatest need and will provide direct support to students in classrooms.

UCCS's plan for extended instructional learning time includes two components. First, academic intervention during after school hours will be made available to all students to provide small group and one-on-one support as needed for all subject areas. Students identified in need of academic support due to credit deficiency, absences from school, and/or additional time will be identified and scheduled for specific times. Second, after-school expanded English language development classes will be held and made available ELs. This after school program will target specific supports to students in English language development and English learners in mainstream classes to support study skills and progress towards language proficiency.

Lastly, the school will add additional Chromebooks to student learning hubs which are available after normal school hours as well as making Chromebooks available for students to check out for at home use. This technology will be used to directly support students that are credit deficient in order to provide additional time for assignment completion and providing resources to make up work missed during absences since absenteeism is an ongoing issue throughout this time. Additionally students can utilize these Chromebooks to accelerate their reading comprehension via Achieve 3000 (Reading), IXL (Math) and other school resource. A majority of students perform below grade level on reading and math; making resources available to them for additional daily practice will help to achieve our goal to close learning gaps that exists amongst our students and exacerbated by the struggles of the Covid19 pandemic.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

Previous funding was used to support distance learning including technology, Wi-Fi assistance, and expanded online instruction during the 2020-2021 school year.

ELO Grant funds are being used to target in-person instruction and supports, with special attention to instructional support for English learners, students with an IEP/504, students performing below grade level and students that are at risk of not graduating. Additional in-class supports will be added along with extended hours for students to receive additional instruction to address learning loss.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students’ college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students’ social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
